Application to Art in the Park – Season 2016-2017 (updated 5/30/16)

ELIGIBILITY: Current, active members of the Vero Beach Art Club (VBAC) may apply for participation in Art in the Park (AIP) if they meet these criteria: VBAC dues must be current. Member must have served at least 15 hours of recorded volunteer service hours in the previous twelve months before the current season begins, (in certain conditions, twelve months prior to 1st show) and member must have attended at least three VBAC meetings during that period.

Complete the application, and send electronically or to Attn: Art in the Park at info@verobeachartclub.org or print, complete and mail to Vero Beach Art Club, 3001 Riverside Park Drive, Vero Beach FL 32963.

When applying to be an exhibitor for AIP, all exhibitors, ("WHO ARE NOT REGULARS") must submit (via email or postal mail) a photo of their tent and booth display. Also submit three photos (or note the link on your website address or indicate VBAC Artist Gallery) of your best art or craftwork.

All exhibitors must submit an application along with a green volunteer card or photocopy with a record of their volunteer hours. This includes all exhibitors, including committee chairs from any of the Art Club functions. If you are a committee chair for UTO, Art by the Sea or any other Art Club function, just state it on your volunteer card.
